Teaching the practical part of Drug Information for students of the third level Pharm D (clinical pharmacy program) in the second semester of the academic year 2021/2022 at the Department of Clinical Pharmacy.

Summer training in the field of drug information for students of the fifth level clinical pharmacy program for the academic year 2021/2022.

Practical Student training in the field Drug Information

- The practical training was held at the Faculty of Pharmacy - Tanta University, which was organized by the Drug and Poison Information Center for students of the Clinical Pharmacy Program (Credit Hours) in the field of drug information, which started on June 28, 2021.
- The training was conducted by the DPIC's staff and was attended by 128 students of the 5th level.
- In compliance with the precautionary measures and in order to activate the conditions for social distancing, the students were divided into 3 groups over the course of 3 consecutive weeks.
- The training achieved its practical goals, which included acquiring the students the ability to deal with all drug information resources pharmacy with full coverage of drug information services, and all other vital career needed skills.



Student training for the Educational Pharmacy

- To complement the efforts of the Faculty of Pharmacy - Tanta University in serving the scientific and professional community in the pharmaceutical field.
- Two training courses were held over two weeks for students of the Faculty of Pharmacy, Tanta University, from September 19-24, 2020 for the first session, and from September 26 to October 1, 2020 for the second session, with 18 training hours/week/cycle, attended by 10 students in the first session, in addition to 8 Students in the second session due to commitment to all precautionary measures to confront the emerging corona virus.
- The training achieved its practical goals, which included acquiring the trainees the ability to deal with patients inside the pharmacy with full coverage of drug information services, and all other vital career needed skills.
- The training was carried out by members of the Drug and Poison Information Center, in the cooperation of a number of faculty members.

Training of students of the clinical pharmacy program (credit hours), level five, at the Faculty of Pharmacy in Tanta Basic Principles in Drug Information Service for student training

The center's pharmacists trained the 140 students of the fifth level clinical pharmacy program in the college from April 7 to May 2, 2019 for the 2018/2019 academic year. Students have to work in this professional field of clinical pharmacy. A questionnaire was made and distributed to the students at the end of the training in order to evaluate it and benefit from the students' observations to raise the level of training, and the result of the general evaluation was excellent.

Training students of the fifth level clinical pharmacy program at the Faculty of Pharmacy - Damanhour University Basic Principles in Drug Information Service for student training

The center's pharmacists trained the students of the fifth level clinical pharmacy program at the request of the Clinical Pharmacy Department at the Faculty of Pharmacy - Damanhour



University. Their number was 14 students and they were trained at the Drug and Poison Information Center at the Faculty of Pharmacy - Tanta University on Saturday 6/4/2019 for a

period of five hours and included Training An explanation of a simplified theoretical part about the tasks and mechanism of work in the drug information centers and a practical training attached to it. A questionnaire was made and distributed to the students at the end of the training in order to evaluate it and benefit from the students' feedback to raise the level of training. The result of the general evaluation was excellent.

Student training for the educational pharmacy program at the Faculty of Pharmacy, Tanta University

The organization and training of the pharmacists of the Drug and Poison Information Center in the college was carried out in cooperation with the assisting body in the departments of the college, in addition to the cooperation of the Sedco Pharmaceutical Company represented by Dr. Amal Jabr. The training took place over 4 weeks with the attendance of 62 college students from July 13, 2019 to September 5, 2019. At the end of each week, a questionnaire was made and distributed to the trainees in order to evaluate the training and benefit from the trainees' feedback to raise the level of training service, and the overall result of the questionnaire was excellent.
